3. No delayed broadcast will be permitted until at least twenty-four (24) hours after the conclusion of the conclusion of that contest.

5. Only the station in this contract can broadcast this contest on their station.
6. Station is required to broadcast four (4) 30-second commercials in each postseason game for the official WVSSAC presenting sponsor of the event at no cost to the WVSSAC or its event presenting sponsor. The commercials will be provided by the WVSSAC.
7. Station agrees to cause its on-air announcers to use the WVSSAC's event presenting sponsor name within the official name of the event during each postseason game broadcast and any on-air promotions of the broadcast at no cost to the WVSSAC or its event presenting sponsor.
8. Station will cause its on-air announcers to read a minimum of one (1) time per game promotional announcements provided by the WVSSAC at no cost to the WVSSAC or its sponsors.

9. Arrangements:

- A. All arrangements must be made in advance of the contest through the game director.
- B. The two stations representing the two participating schools shall be assigned to the best facilities.
- C. There shall not be any criticism of the game officials and their decisions either directly or indirectly.
- D. A maximum of three (3) passes will be provided for any broadcast crew.
- E. The rights to any future use of accounts of the contest for commercial purposes are reserved by the WVSSAC.
