11. Good of the Order (Other Business)

David Price presented an additional item of business (under Request for Waiver) concerning discontinuing wrestling in three Ohio County middle schools. Meredith Dailer recused herself from this discussion.

On a motion by James Crawford and a second by Chad Quesenberry, the Board voted unanimously to not approve the consolidation of four middle schools in Ohio County for wrestling.
